## SUMMARY ANNUAL REPORT FOR THE IRON WORKERS OF WESTERN PA PROFIT SHARING PLAN

This is a summary of the annual report for the Iron Workers of Western PA Profit Sharing Plan, Employer Identification Number 25-1318890, for the period January 1, 2015 through December 31, 2015. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### BASIC FINANCIAL STATEMENT

Benefits under the Plan are provided by a Trust. Plan expenses were \$18,830,309. These expenses included \$513,340 in administrative expenses, \$58,500 in investment manager fees, and \$18,258,469 in benefits paid to participants and beneficiaries. A total of 2,230 persons were participants in or beneficiaries of the Plan at the end of the year, although not all persons had yet earned the right to receive benefits.

The net assets of the Plan, after subtracting liabilities, was \$171,997,808, as of December 31, 2015, compared to \$178,354,303, as of January 1, 2015. During the Plan year, the Plan experienced a decrease in its net assets of \$6,356,495. This decrease included unrealized appreciation or depreciation in the value of the Plan's assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year.

Including employer contributions of \$10,924,471 and earnings from investments of \$1,549,343, the Plan had a total income of \$12,473,814.

- 4) Information regarding any common or collective trust, pooled separate accounts, master trusts or 103-12 investment entities in which the plan participates.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report.

You also have the legally protected right to examine the annual report at the main office of the Plan (2201 Liberty Avenue, Pittsburgh, PA 15222), and at the U.S. Department of Labor in Washington, DC or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
